We are writing to inform you of certain changes relating to the Sub-Fund, which is summarised below.

# A. <u>Appointment of Schroder Investment Management Limited as the sub-manager of the</u> Sub-Fund

Currently, Schroder Investment Management (Hong Kong) Limited is the Manager of the Sub-Fund and Schroder Investment Management (Singapore) Ltd is the sub-manager of the Sub-Fund.

With effect from 20 January 2025 (the "Effective Date"), in addition to Schroder Investment Management (Singapore) Ltd, the Manager will also appoint Schroder Investment Management Limited to act as a sub-manager of the Sub-Fund ("Appointment"). The Manager considers that such appointment will enable the Sub-Fund to tap on the strength of Schroder Investment Management Limited's investment expertise and utilise the investment management resources available within the Schroders group. Accordingly, the Manager considers that the Appointment will benefit the unitholders of the Sub-Fund as a whole.

Schroder Investment Management Limited is a company incorporated in England and Wales, whose registered office and principal place of business is at 1 London Wall Place, London, EC2Y 5AU. Schroder Investment Management Limited is authorised and regulated by the Financial Conduct Authority and is part of the Schroder group.

## B. <u>Implication of Change</u>

Save as described in Section A above, all other features of the Sub-Fund, including fee level, fee structure and risk profile, will remain unchanged, and there is no change in the operation and/or manner in which the Sub-Fund is being managed. The Appointment will not result in any material prejudice to or other effects on the rights or interests of unitholders of the Sub-Fund.

The aggregate fees and costs incurred in connection with the implementation of the Appointment for the Sub-Fund (including amendments to the Explanatory Memorandum and Product Key Facts Statement of the Sub-Fund) are estimated to be HK\$50,000 and will be borne by the Sub-Fund.

Unitholders are not required to take any action in respect of the Appointment. Unitholders of the Sub-Fund may nevertheless elect to redeem or switch out from the Sub-Fund to other unit trusts or mutual funds offered by the Manager and generally available to investors for switching in, before the Effective Date free of any redemption charge and initial charge in accordance with the procedures provided in the Explanatory Memorandum of the relevant Sub-Fund.

## C. Availability of documents

To reflect the Appointment, the Explanatory Memorandum and Product Key Facts Statement of the Sub-Fund will be amended, and the same will be available on or after the Effective Date at our website (<a href="https://www.schroders.com.hk">www.schroders.com.hk</a>) or upon request from our office (Level 33, Two Pacific Place, 88 Queensway, Hong Kong) free of charge.

## B. 更改的影響
