JPMorgan Global Bond Fund

We are writing to inform you about certain changes to JPMorgan Global Bond Fund (the "Fund").

With a view to leverage on the investment management capabilities and resources of the JPMorgan group, the Investment Manager will appoint JPMorgan Asset Management (UK) Limited as Sub-Manager of the Fund with effect from and including 14 May 2025.

The fees of the Sub-Manager will be borne by the Investment Manager.

Save as disclosed above, there will be no change in the operation and/or manner in which the above Fund is being managed. The above changes will have no impact on the investment objective, features and the overall risk profile of the Fund or the fee level/cost in managing the Fund. The Manager is of the opinion that the above changes will not materially prejudice the rights or interests of existing investors of the Fund.

The legal and other administrative costs associated with the change above, estimated to be approximately USD 6,500, will be borne by the Fund.

If, as a consequence of the changes above, you wish to redeem or switch your holding in the Fund into any other funds which are managed by JPMorgan Funds (Asia) Limited or for which it acts as Hong Kong representative¹ and which are authorised by the Securities and Futures Commission for sale to the public in Hong Kong, you may do so free of charge during the waiver period between 14 April 2025 and 13 May 2025² in accordance with the dealing procedures set out in the latest offering document of the Fund. Prior to switching to such funds, investors should read and understand the investment objective, policies, risks factors, fees and other information applicable to such funds as described in the relevant Hong Kong offering documents.
