- 1 Manulife Hong Kong Series Manulife Global Multi-Asset Diversified Income Fund (the "Fund") is a feeder fund that invests all or substantially all of its assets in the Manulife Global Fund Global Multi-Asset Diversified Income Fund (the "Master Fund").
